Confirmation of Definitive Map Modification Order Wildlife and Countryside Act 1981 – Section 53

The Cornwall Council (Upgrade of Part of Footpath 2 Tregony to Restricted Byway and Addition of Restricted Byways in the Parishes of Tregony and Cuby)) Modification Order 2016

The abovementioned order was made by Cornwall Council on 14 December 2016. The Order was subsequently confirmed by the Secretary of State with modifications on 3 May 2018. As required by Schedule 15 Paragraph 11(1),(2) and (3) to the Wildlife and Countryside Act 1981 Cornwall Council hereby gives notice of the confirmation of the order.

This Definitive Map Modification Order made under Section 53(2)(b) of the Wildlife and Countryside Act 1981 came into force on the day that it was confirmed. After that date the public path added to the Definitive Map and Statement by the order will exist as a highways.

A copy of the required notice and a copy of the order as confirmed are enclosed. Please note that any applications to the High Court in respect of the validity of the order or the statutory procedures must be made in the required manner within six weeks of the date of the notice.

On 3 May 2018, the Secretary of State for the Environment confirmed with modifications the above order made under section 53[(2)(b)] of the Wildlife and Countryside Act 1981.

The effect of the order as confirmed is to modify the definitive map and statement for the area by upgrading a length of existing Footpath No. 2 in the Parish of Tregony to be upgraded to Restricted Byway commencing at its junction with Byway Open to All Traffic No. 4 Tregony on "Well Lane" approximately 299 metres west-north-west of "Ryecroft Lodge" at Ordnance Survey Grid Reference (OSGR) SW 9232/4472, thence continuing in a generally east-south-easterly direction for 325 metres to a point approximately 35 metres south of "Ryecroft Lodge" where the path is in moiety between the parishes of Tregony and Cuby at OSGR 9262/4462 shall be upgraded to Restricted Byway, thence continuing in a generally easterly and then south-easterly direction for 103 metres to a point approximately 114 metres south-east of "Ryecroft Lodge" where it connects with a Restricted Byway to be added by this order at OSGR SW 9270/4458, thence continuing in a generally south-south-westerly direction for a distance of 23 metres to a point 116 metres southeast of "Ryecroft Lodge" at OSGR SW 9269/4456, thence continuing in the parish of Tregony in a generally south-south-westerly direction for a distance of 10 metres to a point where it connects with a footpath added by "The County of Cornwall (Addition of Footpath from Footpath No. 2 Tregony to Footpath No. 23 Veryan) Modification Order 2007 and another Restricted Byway to be added by this order approximately 123 metres south-east of "Ryecroft Lodge" at OSGR 9268/4455. The order will also modify the definitive map and statement for the area by adding a length of Restricted Byway in the Parish of Cuby commencing at Unclassified Road U6098 ("Cuby Road") approximately 462 metres north-east of "Ryecroft Lodge" at OSGR SW 9298/4493, thence running in a generally south-westerly westerly and then south-south-westerly direction for a distance of 505 metres and terminating at its junction with Footpath 2 in Tregony (to be upgraded to Restricted

Byway by this Order) at the Tregony-Cuby parish boundary approximately 114 metres south-east of "Ryecroft Lodge" at OSGR SW 9270/4458. The order will also modify the definitive map and statement for the area by adding a length of Restricted Byway in the Parish of Tregony commencing at a junction with Footpath No.2 Tregony (to be upgraded to Restricted Byway by this Order) and a footpath added by "The County of Cornwall (Addition of Footpath from Footpath No. 2 Tregony to Footpath No. 23 Veryan) Modification Order 2007 approximately 123 metres south-east of "Ryecroft Lodge" at OSGR SW 9268/4455, thence running in a generally south-south-westerly direction for 630 metres terminating at County Road A3078 in the hamlet of 'Reskivers' approximately 662 metres south-south-west of "Ryecroft Lodge" at OSGR SW 9237/4404.

A copy of the order as confirmed and the order map have been placed and may be seen free of charge at the Offices of Cornwall Council at Truro One Stop Shop, Pydar House, Pydar Street, Truro TR1 1XU from 10:00 am to 4:00 pm on Mondays to Fridays inclusive. (Public and Bank Holidays excepted) Copies of the Order and map may be bought there at the price of £5.00.

The order comes into force on the day that is it confirmed but if any person aggrieved by the order wants to question its validity on the ground that that it is not within the powers of Section 53 of the Wildlife and Countryside Act 1981, or on the ground that any requirement of Schedule 15 of the Act has not been complied with in relation to the Order, he or she may under paragraph 12(1) of Schedule 15 to the Act, within six weeks from the date on which notice is first published, make application to the High Court.

This Order is made by Cornwall Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the definitive map and statement of public rights of yay for the former Carrick district area requires modification in consequence of the occurrence of an event specified in Section 53(3)(c)(ii) of the Act, namely the discovery of evidence that a highway shown in the map and statement as a highway of a particular description ought to be there shown as a highway of a different description, and an event specified in Section 53(3)(c)(i) of the Act, namely the discovery of evidence which (when considered with all other relevant evidence available) shows that a right of way which is not shown in the Map and Statement subsists or is reasonably alleged to subsist over land in the area to which the Map relates.

The Cornwall Council hereby order that:

- 1. For the purposes of this order the relevant date is 07 October 2016.
- 2. The Definitive Map and Statement of Public Rights of Way for the former Carrick district area shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
- This Order shall take effect on the date it is confirmed and may be cited as, "The Cornwall Council (Upgrade of part of Footpath 2 Tregony to Restricted Byway and Addition of Restricted Byways in the parishes of Tregony and Cuby) Modification Order 2016".



The total length of Footpath 2 to be upgraded is 461 metres. The width of the Restricted Byway described varies between 3 (three) metres and 6 (six) metres, in accordance with the depiction of the way on map sheets Cornwall LXIII.12/& LXIII.16 from the Ordnance Survey County Series Second Edition published at 1:2500 scale.

A length of Restricted Byway in the Parish of Cuby commencing at Unclassified Road U6098 ("Cuby Road") approximately 462 metres north-east of "Ryecroft Lodge" at OSGR SW 9298/4493, shown as point "A" on the map attached to this order thence running in a generally south-westerly westerly and then southsouth-westerly direction for a distance of 505 metres and terminating at its permited இழு junction with Footpath 2 in Tregony (to be upgraded to Byway Open to All Traffic by this Order) at the Tregony-Cuby parish boundary approximately 114 metres south-east of "Ryecroft Lodge" at OSGR SW 9270/4458 shown as point "B" on the map attached to this order.


